- ii) No request for upward revision in the contract rates will be entertained during the currency period of the contract.
- iii) At the time of payment of bills, TDS and/or any other tax, surcharge etc., shall be deducted as per Government rules and guidelines, applicable from time to time.
- iv) The rate should be quoted F.O.R destination.

3. PERIOD OF VALIDITY OF BIDS

- i) Bids shall remain valid upto 31.03.2019.

4. RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS
